## SUMMARY

The American Recovery and Reinvestment Act (ARRA) was signed into law on February 17, 2009 and appropriates \$787 billion for measures that will modernize our nation's infrastructure, enhance energy independence, expand educational opportunities, preserve and improve affordable health care, provide tax relief, and protect those in greatest need. The Recovery Act includes \$1 billion in Community Development Block Grant – Recovery (CDBG-R) funds to support a broad range of housing and community development projects that are “shovel-ready”, i.e., can be implemented as soon as possible.

The Charter Township of Redford is an Entitlement Grantee in the U. S. Department of Housing and Urban Development (HUD) CDBG Program.

Under ARRA, Redford Township has been allocated \$261,229 in CDBG-R funds, which are supplemental to the regular CDBG program. Submittal of a complete application is required to HUD by June 5, 2009.

HUD requires that all grantees receiving CDBG-R funds under ARRA complete a substantial amendment to their 2008 Annual Action Plan. Redford Township proposes to amend the 2008/2009 Annual CDBG Action Plan to allocate \$261,229 to fund various activities as outlined throughout this document.

### ***A. SPREADSHEET FOR REPORTING PROPOSED CDBG-R ACTIVITIES***

Grantees must provide information concerning CDBG-R assisted activities in an electronic spreadsheet provided by HUD (See Appendix – CDBG-R Activity Data Spreadsheet). The information that is reported in the spreadsheet includes activity name, activity description, CDBG-R dollar amount budgeted, eligibility category, national objective citation, additional Recovery Act funds for the activity received from other programs, and total activity budget. The electronic copy of the will be emailed to HUD on June 5, 2009.

The Charter Township of Redford has proposed 11 activities. All non-planning and administrative CDBG-R funds will either benefit low and moderate income persons or areas that are considered by HUD to be low and moderate income areas. The Township has allocated 9.5 percent toward administration and 9.2 percent toward public services.

**B. CDBG-R INFORMATION BY ACTIVITY (COMPLETE FOR EACH ACTIVITY)**

**(1) Activity Name: Housing Rehabilitation**

**(2) Activity Narrative:**

The Housing Rehabilitation activity meets an identified need to provide low and moderate income persons improved access to decent, affordable housing that is also energy efficient.

A Pre-Construction Housing Inspection will be made by the Housing Rehabilitation Department to determine the extent of the necessary repairs/rehabilitation. Modernization, new construction and homes requiring “reconstruction” do not qualify for this program. All rehabilitations will be completed to meet energy efficient building codes which can include but is not limited to:

- Roof and gutter replacement
- Storm door replacement
- Vinyl siding replacement
- Driveway, sidewalk, walkway and porch replacement
- Electrical service update
- Furnace replacement
- Plumbing repairs
- Hot water heater replacement
- Bathroom and kitchen repairs
- Vinyl flooring replacement
- Glass block window installation

Eligible homeowners are residents who:

1. Own and live in their own home for one year
2. Meet the income eligibility requirements
3. Live in a selected target area/neighborhood.

*(Amount of equity in the home and credit rating are not considered when determining program eligibility).*

The installment payment loans (Real Estate Mortgage) are secured at a fixed Annual Percentage Rate of 4% (four percent) and may be re-paid over a period of ten (10) years. Deferred payment loans (Grant Mortgage) do not require repayment unless the rehabilitated property is sold or transferred within ten (10) years. Both installment payment loans and deferred payment loans are secured by a recorded mortgage held by the Charter Township of Redford. The maximum amount allocated per Housing Rehab project is \$ 5,000.00.

A three-member Rehabilitation Review Board will authorize the approval of all loans and grants. Every effort will be made to work with residents desiring to take advantage of the Housing Rehabilitation Program, and every consideration will be given to those receiving loans to make repayment schedules as easy as possible.

The units addressed will be made more energy efficient as a result of the rehabilitation work. Improvements may include window and/or door replacements, the addition of siding and/or insulation and various other renovations that will foster energy conservation.

In addition, housing rehabilitation will help foster economic recovery through the creation of temporary construction jobs.

Davis Bacon Labor Standards will be incorporated into the specification packet, as well as the Buy American provisions required under Section 1605 of the Recovery Act. Funding allocations are contingent upon the satisfactory completion of an Environmental Review.
